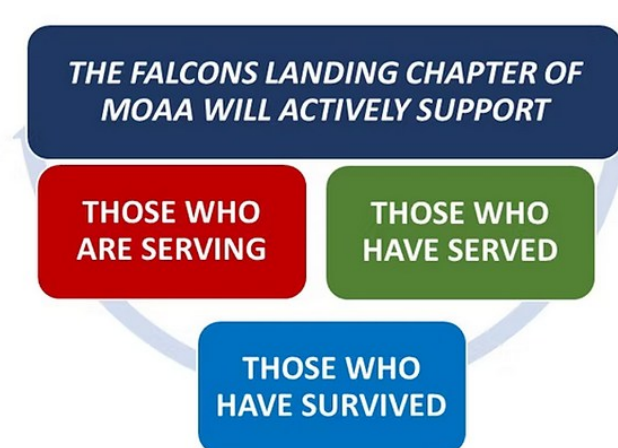

CHAPTER PRESIDENT'S MESSAGE

DECEMBER 2025

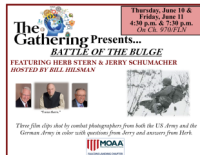

2026 FACT SHEET

The Military Officers Association of America (MOAA) is the nation's largest and most influential association of military officers. It is an independent, nonprofit, politically nonpartisan organization.

The Falcons Landing Chapter (FLC) is one of more than 400-plus local organizations affiliated with National MOAA and is a member of the Virginia Council of Chapters. The Chapter is located at Falcons Landing, a Life Plan Community which is operated by the Air Force Retired Officers Community (AFROC). It is the only MOAA Chapter in Loudoun County. The Chapter is also a member of the **Virginia Council of Chapters, MOAA**.

The mission of the Chapter is to provide programs to support: *those who are serving; those who have served; and those who have survived*, while placing special focus on community support.

Chapter membership is open to those who hold, or have ever held, a warrant or commission in any component of the Army, Marine Corps, Navy, Air Force, Coast Guard, Space Force, Public Health Service, NOAA, and their surviving spouses. As of November 20, 2025, there were 122 Premium Members and 68 Auxiliary Chapter Members for a total of 190 Chapter Members.

The most significant, ongoing program for the Chapter is the multifaceted local support to veterans and their families. The Chapter established the **Loudoun Veterans and Family Support (LVFS)** program in partnership with Community Lutheran Church of Sterling, providing financial and general support to Loudoun County Veterans needing assistance.

The Chapter strongly supports the **Loudoun County Community Veterans Engagement Board (LCCVEB)**, whose purpose is promoting a healthy and enriched lifestyle for Loudoun County veterans and their family members through community outreach and advocacy on Loudoun County veterans' issues.

The Chapter sponsors the ***Gathering***, a program of distinguished guest speakers for monthly presentations on current and past world and government affairs.

The Chapter has established a ***Speakers' Bureau***. This initiative is in keeping with the chapter's goal of continuing to inform the American public about their military establishment. This program has been temporarily suspended until further notice.

Four times a year the Chapter supports the ***AdoptaPlatoon Soldier Support Effort***® dedicated to quality of life and raising morale for those serving overseas in the Army, Air Force, Navy, Marine Corp, serving deployed United States Service Men and Women by providing ongoing care packages to improve Coast Guard and Special Forces.

The Chapter supports three ***Junior ROTC*** units in our area of responsibility: the Air Force JROTC unit at Chantilly High School in Fairfax, the Navy JROTC unit at Loudoun County High School in Leesburg, and the Army JROTC unit at South Lakes High School in Reston. The Chapter President and Director of JROTC Programs present scholarships to selected cadets at each school. In addition, the Lieutenant General John Pustay Scholarship is awarded to a selected cadet at Chantilly High School.

Memorial and Veterans Day Programs are presented each year at Falcons Landing.



ANNUAL MEETING MINUTES SUMMARY

DONNA EVERAGE

The annual meeting of the MOAA Chapter was held at 3:00 p.m. on November 20, 2025, in the Falcons Landing Ballroom. All Directors and Officers were present with the exception of Barbara O'Brien, Ed Post, Joe Miller, Howard Schue, Bill Suter, and Don Saari.

INTRODUCTION OF PROSPECTIVE OFFICERS AND DIRECTORS

New candidates for Officer and Director positions were introduced to the Chapter. Those individuals were Ken Evans, Jim Fontana, George DeFilippi, and Denny Morin.

CHAPTER HISTORY AND MISSION

Upon completion of the Pledge of Allegiance and Opening Prayer, Phil Walsh provided a review of the Chapter's History, detailed the purposes of Falcons Landing, and presented the Mission Statement.

OFFICERS AND DIRECTORS

During the presentation of the current Board of Directors, Phil noted the individuals who would be stepping down from their positions at the end of 2025. At the conclusion of the meeting, an election was conducted to elect the new Officers and Directors. Phil made a motion to elect the following proposed slate of Officers and Board Members: Ken Evans for Chapter President, Jim Fontana for Vice President of Legislative Affairs, George DeFilippi for Treasurer, and Denny Morin for JROTC Coordinator. The motion was seconded by Jerry Galloway. A vote was taken, and the motion passed unanimously.

Phil also publicly recognized Peter Scott for his significant contributions to the Chapter, particularly assisting in recruiting a slate of officers to help run the Chapter.

MEMBERSHIP

Buddy Everage gave a presentation on membership, highlighting that while the number of military service members is decreasing, the population of non-military residents is increasing. As a result, it is anticipated that, over time, membership in the Chapter will continue to decline. During this segment, Phil also announced the passing of Ward O'Brien, a valued member of our MOAA Chapter.

Phil further remarked that the membership challenges experienced by the Chapter are consistent with those discussed at national MOAA meetings. To address declining membership, MOAA has established a national database and is making a concerted effort to inform Chapter membership directors about national MOAA members residing in their areas, encouraging them to join local chapters.

FINANCES

Richard Searles provided an in-depth review of the Chapter's financials. The Chapter conducts an annual donation campaign to fund operations for the upcoming year, setting a target goal based on anticipated expenses. The primary expenditures are for JROTC scholarships and the Loudoun County Veterans and Family Support (LVFS) program.

FALCONS LANDING MOAA CHAPTER PROGRAMS

Phil discussed the Chapter's programs, noting that LVFS funding was especially critical last year due to increased program costs. In February, a Special Board meeting was held to reassess funding priorities. As a result, the Board decided to reduce JROTC scholarships from \$9,000 to \$6,000 (\$2,000 per school) to ensure sufficient funds for ease visibility and membership, the Chapter published an article in the Falcons Landing newsletter and produced a commercial about MOAA for Channel 970, which will be aired again this year.

CHAPTER ANNUAL UNDERTAKINGS AND MAJOR EVENTS

The Chapter's two major events—Memorial Day and Veterans Day—were successfully held, due in large part to the efforts of Bob Manning and Dave Nordeen. The Chapter also submitted applications for the Levels of Excellence (LOE) Award and Communications Awards. The Chapter was honored with 5-star distinctions for the LOE award and for both the MOAA Newsletter and Website awards.

Peter Scott collaborated with the Resident Council to provide all residents with new ID cards, resulting in nearly all residents receiving updated identification. Peter also led the detailed application process for the LVFS financial grant from MOAA National; all funds from this grant directly support veterans. Since 2016, the LVFS model developed by the Chapter has been emulated nationwide. This year, the Chapter received a \$3,500 grant from MOAA National specifically for the LVFS program.

The national database's committee module was updated, and the Chapter is responsible for keeping its information current. This year, the database transitioned to an entirely new software system, and Phil thanked Buddy Everage for assisting with this process.

Ben Romero presented a review of The Gathering events, which were held in 2025 and are scheduled again for November and December.

The 2026 Chapter meeting dates were announced.

MOAA'S ACTIVE ADVOCACY CAMPAIGNS

Listed below is a summary of the current Active Advocacy Campaigns being conducted by MOAA. As chapter members of MOAA you are encouraged to participate in those areas that are of particular interest to you. Support for Military Spouses: Advocating for the inclusion of military spouses as a target group under the Work Opportunity Tax Credit to combat their high unemployment rate.

TRICARE and Health Coverage:

- Opposing the end of GLP-1 coverage for TRICARE For Life retirees.
- Calling for expanded TRICARE eligibility for Guard and Reserve members who are federal employees.
- Supporting coverage of assisted reproductive technology, including IVF, for service-members and their families.
- Seeking to expand TRICARE Young Adult eligibility up to age 26.
- Promoting improved access to OB-GYN and prenatal care for military families.

Veteran Support and Benefits:

- Urging passage of the Veteran Caregiver Reeducation, Reemployment, and Retirement Act to support veteran caregivers.
- Advocating for legislation to provide timely care for toxic-exposed veterans.
- Supporting the Fairness for Servicemembers and Their Families Act to update life insurance coverage in line with inflation.
- Pushing for increased Dependency and Indemnity Compensation for surviving spouses.
- Backing the Love Lives On Act to protect the right of surviving military spouses to remarry and retain benefits.
- Endorsing the Major Richard Star Act amendment to correct pay offsets for medically retired veterans.

Military Family Quality of Life:

- Seeking restoration of full Basic Allowance for Housing (BAH).
- Addressing hazardous unaccompanied housing conditions in the military.
- Improving access and reporting for care at Military Treatment Facilities (MTFs).
- Advocating for leave policy parity for U.S. Public Health Service Commissioned Corps members.



MOAA'S ACTIVE ADVOCACY CAMPAIGNS (continued)

Financial Protections: Calling for the resumption of Consumer Financial Protection Bureau (CFPB) operations to safeguard servicemembers from predatory financial practices.

Sexual Trauma and Disability System: Supporting the Servicemembers and Veterans Empowerment and Support Act to improve care for survivors of military sexual trauma and defending the integrity of the VA disability system.

THE GATHERING: TRENCH WARFARE

During the August Gathering meeting our guest speaker, CAPT Kevin Cropp, USN (Ret), presented a historical discussion based on Trench Warfare in WW I. That war started in 1914 and continued until 1918. It involved Germany and European Allied Forces and was known for the role of trench warfare. During that period, a number of innovations in warfare were developed including tanks, aircraft, artillery, machine guns, and chemical weapons, as well as tactics and methods of operation. The most prominent figure from the war was the development of a stalemate on the Western Front, which consisted of a near continuous line of trenches from the English Channel to Switzerland.

The trenches were an elaborate construction that allowed the troops of both sides to have shelter from opposing forces. During the war, the forces developed routines of daily operation, with new methods for providing food, medical support and logistical support for weapons, as well as new clothing for winter and summer. Soldiers often provided clothing supplies from home for protection in winter weather. The dress often was related to clothing from the local lifestyle. For example, the Scots used kilts. Soldiers wore soft hats for the first part of the war until helmets were introduced in 1916. Food included hard tack, bully beef and spam.

Our guest speaker provided a number of details and examples about weapons systems and details on trenches and styles of weapons, which created an interesting presentation on the time period from the Great War! Our thanks to CAPT Cropp.





THE GATHERING: PAKISTAN DISASTER RELIEF

The Gathering presentation on September 18 featured as our guest speaker VADM, USN (Ret.) Michael LeFever. He presented a discussion of his role as Commander of a task force providing disaster relief to the people of Pakistan after a major earthquake in 2005, which left 80,000 dead, 178,000 injured and 3,000,000 people homeless. The United States had medical support, transportation, food and water, and a requirement to deliver support to a country that had limited resources and did not necessarily want U.S. presence. His challenge as the US Commander assigned to the mission of Commander, Disaster Assistance Center Pakistan for US relief was to find a means of delivering support and saving lives, starting with about 48 hours of lead time.

What we learned during his presentation was not just the role of military strength, but rather the nature of US citizens – both in the military and with other U.S. relief organizations, to provide humanitarian support to people in need. Working with local leaders and with the community of Pakistani people, plus with relief organizations from other nations, they combined to help Pakistan return to a new normal and to build a stronger relationship between Pakistan and the US.

US support consisted of providing medical supplies that were the equivalent of two MASH hospitals, as well as transportation, including critical helicopters to reach remote distances across Pakistan. It also included equipment support in helping rebuild local communities. Admiral Lefever pointed out the value of building long-term relationships that paid dividends in trust between the US and Pakistan that came into focus during a flood in 2008, when the US again provided critical support.

The details of this support can be found in a book by Admiral Lefever called “End Game First.” It focuses on strategic planning, including entry planning and an exit endgame, leadership, and relationships, plus the ability to react with flexibility to rapidly changing situations in unfamiliar environments.

Admiral LeFever was recognized by Pakistan with the award of “Hilal-i-Quaid-i-Azam” (Order of Great Leader) from the President of Pakistan.

INAUGURAL TOTALFORCE+ CONFERENCE SUMMARY

OCTOBER 28-29



MOAA's first-ever TotalForce+ conference was held at the Gaylord National Resort and Convention Center in National Harbor, Maryland, concluding on October 29, 2025.

The event brought together a diverse group of participants, including service and industry leaders, social media influencers, celebrities, advocates, decorated veterans, and numerous other stakeholders.

Throughout its two days, the central message remained clear and succinct: "People matter." This guiding principle shaped the discussions and initiatives presented at the conference.

Attendees had the opportunity to connect with dozens of exhibitors, listen to a variety of speakers, and engage with special guests. The sessions addressed a wide array of personnel-related topics and challenges affecting both active service members and veterans, as well as their families.

Lt. Gen. Brian T. Kelly, USAF (Ret), President and CEO of MOAA, delivered remarks on the main stage, emphasizing the importance of positive collaboration within the total force community. He highlighted the conference's role in providing a forum for stakeholders to come together, share meaningful solutions, and establish lasting connections. Kelly expressed optimism that TotalForce+ would become a regular event shaping the total force landscape.

The conference began on a high note with a keynote speech from former Army Staff Sgt. Salvatore Giunta, a Medal of Honor recipient recognized for his actions in Afghanistan on October 25, 2007. Giunta recounted his journey to military service, which started with his enlistment in 2003, and spoke to a packed audience about the power and value of the all-volunteer force.

Giunta's remarks resonated with attendees, as he stressed that meaningful contributions to a team do not require participation in combat or enduring hardship. Instead, he encouraged everyone to be useful to others and focus on collective achievement rather than individual recognition, underscoring the extraordinary accomplishments that are possible when credit is not the priority.
